Summary Report from Core of Engineers explanation of water movement on Lake Osakis. The main water flow (50%+) is from JD2 (Miller Bay) to the outlet. Water coming from the North and South converges with this mass flow and is directed to the outlet. Therefor the nutrients and algae from either end of the lake do not travel beyond the mass flow region. Algae blooms and vegetative growth nutrient source is most likely originate in the areas they are found. In other words, the source problem is more localized.
